Supported Employment in Action: Greg McCann celebrates 25 years on the job



Twenty-seven years ago the mission and vision of WOI began a shift outside these walls and into other areas of our community. Classroom work focused on preparations to enter the workforce, job coaches were hired, and interviews for jobs in the community began. In 1992, Jeff Cook, Manager of McDonald's of Boone, interviewed Greg McCann and hired him as Lobby Host. That was 25 years ago, and Greg is still on the payroll at McDonalds in Boone! Greg was the 4<sup>th</sup> employee hired through the new Supported Employment program; WOI

has since placed over 1,100 individuals in competitive community jobs. Greg's co-workers and friends gathered at McDonald's on September 1<sup>st</sup> to help Greg celebrate the occasion. Over the years, his duties have expanded from the Dining Room and parking lot to also include kitchen duties. When asked about his many years at McDonald's, Greg states, "I love it".

When not at work, Greg participates in the Follow Along program, which offers vocational supports geared towards maintaining both employment and community immersion. Through this

program, Greg has become an active member in the community. He has been volunteering at the COC Food Pantry for over 9 years! Greg's steady income has enabled him the opportunity to pursue his hobby of fishing and other interests over the years.

Greg's accomplishments have not gone unnoticed. On October 3rd Greg traveled to the annual MARC meeting at Lake Junaluska and was very pleased to receive the Marion and Frances Fairey Employee Longevity Award—"in Recognition of your long and faithful record of work and for serving as a 'Cause Ambassador". Our group of North Carolina advocates met with numerous Members of Congress and legislative staff to tell our stories and express our concerns about current laws and regulations that limit or restrict government supports for services and employment options that ensured personal choice from an array of options and opportunities.


Mike Haworth, WOI Parent from Ashe County NC, stated, "Cindy and I are thankful for the North Carolina legislators and staff that took time out of their busy schedules to listen to our concerns about the potential impact recent legislation may have on the ability of our daughter Beth to continue to work at Watauga Opportunities. Each of them seemed to appreciate the rather obvious and simple truth that one size does not fit all." All agreed that the trip to the Capitol was a significant opportunity to have a positive impact assuring the same choices of where, how, and with whom they work and spend their time as all other citizens do.



We were pleased that Congresswoman Foxx and staff from

Senators Tillis and Burr's office took time to visit with us during our Day on the Hill event. We look forward to working with them, to address both the unintended negative consequences and unfunded mandates resultant from the regulatory over-reach within implementation of the otherwise admirable Workforce Innovations and Opportunity Act. Our contingent from North Carolina gives a special thanks to ACCSES, a Washington based national association for community rehabilitation programs that coordinated and hosted the Day on the Hill.

**Highlighting 2016-2017:** WOI continues to partner with NC Division of Vocational Rehabilitation, Vaya Health, Watauga County Board of Education and others in the provision of vocational, community and residential services. During FY 2016-2017, Watauga Opportunities provided vocational services to 267 individuals. Our employment programs saw 63 individuals' attain **self-reliance through employment** with Work Adjustment placing 30 individuals while Supported Employment accounted for 33 community job placements. Evaluation/Work Adjustment served 74 individuals, Supported Employment served 49 individuals in job development/training & 85 in Follow-Along, CAET/ADVP served 19 individuals, Innovations served 14 individuals, School Transitional programs served 13 students while our residential programs served 12 individuals in our group homes. We served individuals in Watauga, Ashe, Avery, Alleghany, Wilkes, Mitchell and Buncombe Counties.



Watauga Opportunities continues in our quest to **enable our own self-reliance** through reduction in the use of tax dollars in provision of our services. In FYE 2017, 39% of non-residential operating revenues were self-generated. While the economic impact of Watauga Opportunities is important, the true human impact of our service is best seen in the growth of our participants' own **self-reliance**; since 1994 participant community wages earned are estimated at \$6.83 million, while their government subsidies have reduced by an estimated \$2.73 million. Community job placements now total 1151. We truly are **enabling self-reliance** and **enhancing independence**. The above charts show the source of our revenue and its expenditure.

## 2016-2017 Program Evaluation

Watauga Opportunities, Inc. had many positive outcomes during the past fiscal year. A total of **267** individuals were served as follows:

Supported Employment	49
SE Follow-Along and Group	85

A total of **63** individuals were successfully placed in community jobs. Program participants invested 7,412 hours in community civic and volunteer efforts. Satisfaction surveys from all stakeholders yielded in 98% positive responses of services.

Individuals in the CAET and Innovations Programs participated in a community art project, *Trash to Treasure*, at the Turchin Center during July. ## Manufacturing and Quality News

Looking towards the future, the Manufacturing Dept. has been busy expanding our production for existing customers and cultivating new relationships. One project that we are excited about is with Dana Corporation. Dana produces products worldwide for the automobile industry. We have worked with Dana to help them with a thin gauged thermoformed tray that would hold large washers that go into automobile transmissions. We are now manufacturing a third generation tray for large washers. Our relationship with Barry Callebaut continues. Barry Callebaut is the world's leader in chocolate production. We are producing new items for them on a regular basis, as well as maintaining existing contracts.

This fall, our Quality Department had another successful ISO continual assessment audit. Our quality system is certified to ISO 9001:2008 and ISO 13485: 2003. Next year we will be transitioning to the new ISO 9001:2015 and ISO 13485:2016 standards.

## AKTION Kiwanis Club at NC Conference

Boone AKTION Kiwanis Club members have worked hard on meeting the needs of children in our community in 2017. Projects through COC Food Pantry include the Baby Love Project, the Easter Project, and the Children's Christmas Project. With The Literacy Initiative Project, members purchased children's books for local day care centers and accompanied Boone Kiwanis Club members to deliver books and read to children. The "Pack the Bus" Project raised money for school supplies. Members also prepared lunches and donated proceeds (\$625 total!) to families and children affected by the Hurricanes in 2017.
